hose who are familiar with and watery qualities." Stephanie Reininger's watercolors already know that she is an exceptional artist. Yet her contention that "anyone can do it" makes those of us who know that we're not artists a bit skeptical. Can a beginner be taught to create art akin to hers? She must believe they can because she's been teaching it to beginners for over 40 years and for the last 10 or so at OSHER@Dartmouth. "So long as they learn how to draw first - and almost anyone can be taught to draw - you can teach the techniques of watercolor," she says, "there are images to capture everywhere and I believe in exploiting watercolor's transparent

Stephanie began life in New York City and Connecticut. She spent her wild high school days at the St. Mary's School for Girls, run by Episcopal nuns, in Peekskill, NY. Her parents always encouraged her interest in art and she pursued it at Colby Junior





College (now Colby-Sawyer College) where she took every art course offered. After graduating from Colby's 2-year program she went on to Bennington College where she majored in art and studied every form with the exception of sculpture. Working largely in abstract form, she learned how to make prints, produce acrylics, paint in oil and master the critical skill of drawing. "No nudes at Bennington back then, just models in leotards", she laughs.

After college she got a job at the Metropolitan Museum of Art, in New York City, at The Junior Museum and shortly thereafter met Bill, her

Member giving: We hope you have had a wonderful Holiday Season, and are beginning to think toward the coming warmer months! We are very

happy to report a great participation in the Friends of OSHER@Dartmouth fund raising. As of this writing, we have received over \$23,000 in donations! All of our Friends and Memorial gifts are used directly to improve our offerings: a speaker's podium, AV equipment, and much more come from these funds.

In November there was a devastating house fire in Hartford, which left two children and their grandpar-

ents homeless; without insurance there was no chance of rebuilding. Lisa King and our office staff felt we should attempt to help, and used our community email partners to announce this tragedy. To date, almost \$10,000 in cash, gift cards, blankets, and clothes have been donated. We are very grateful for your kindness and generosity!

Office and classrooms under one roof: We continue to pursue options to bring our office and classrooms closer together. As I have written before, we would like to have most of our classrooms under one roof with our office. It would ease the difficulty in providing support to multiple different sites, and would be much more fun to have a

larger social aspect to our teaching. While we do not have a clear choice yet, I will keep you posted!

New by-laws: This spring you will receive a request to vote upon the new by-laws. The new version will be made available to all online, and in printed form to those who request it from the office. A group of us has worked very hard on bringing what we see to be improvements that will streamline our organization's governance. We will set up several opportunities to meet to discuss the changes, and ultimately we will want all to vote. We hope you will join in this important activity!

Treasurer's Report

Budget Process: December was an-other landmark month for your Finance Committee with our budget for the next fiscal year (year ending June 30, 2019) due in to Dartmouth before the start of the holiday period. This year's budget process once again involved a close collaboration between the Finance Committee and each of the various program committees. Beginning with a training session in September, committee chairs met with the Finance Committee in early November to review and discuss first round budget submissions. Areas for adjustment were agreed, and in early December, second round submissions were rolled up into a final budget proposal that was presented to, and approved by, the Leadership Council in mid-December.

Our goal is to have a budget in which expense and revenue are balanced. The budget that we have submitted to Dartmouth projects a very small (<1%) negative cash balance at June 30, 2019, well within the margin of error. Our projected revenue for the year (\$500,935) is down 1.5% on FY2018. We foresee income from the Osher endowment and from the Summer Lecture Series growing while membership dues and fees from our four terms of courses decline modestly. The budget has no increase in any dues or fees for the next fiscal year.

Budget Line Items: Administration remains our largest single area of expense (69%). Our fixed costs – staff salaries and benefits and our lease expense for DOC House and the 7 Lebanon Street office - continue to be the main drivers of increase in expense in this area, offset to an extent by savings made elsewhere by staff in office operating expenses. Additional savings in expense are projected by the Curriculum and the Marketing Committees. We again plan to dedicate some of the revenue from the Osher endowment to underwrite both the Special Lectures and the



monthly movies at the Nugget – both available at no charge and a great opportunity to introduce a friend to our lifelong learning institute.

We expect the cost of space across all activities – DOC House, 7 Lebanon Street and classroom rental throughout the area – to account for just over 20% of all projected expense in FY2019. Your Finance Committee continues to support the search for new space that will give us better value for the money that we spend.

New Finance Committee members needed. In May 2018 two members of the Finance Committee will be required to step down, each having fulfilled two 3-year terms. If you think you might like to replace one of these retiring stalwarts as a member of the Finance Committee, please come to one of our monthly meetings to "try us out". There is a lot going on beyond pouring over spreadsheets. Contact Lisa King in the office for details.

By-Laws Vote

On January 26, 2018, OSHER@ Dartmouth's Leadership Council voted to accept revisions to our existing by-laws. These revisions were the result of an extensive review of existing by-laws and a desire to provide flexibility in governance and increase the number of people working to improve and govern our organization.

Before our organization can officially accept this revision to our by-laws, we are asking current OSHER@Dartmouth members to weigh in and submit their vote to accept or decline the revisions. (Members can also elect to abstain from the vote.)

To help our members make a decision on this matter, we are posting our current by-laws and the proposed revisions on our website (osher.dartmouth.edu). If you cannot access the web, or prefer a printed copy of these documents, contact the OSHER@Dartmouth office to request a printed packet. Please provide at least 24 hours notice to allow staff members to prepare your packet.

Some of the most impactful revisions to the by-laws include the following items:

 Elimination of the Nominating Committee, to be replaced by the Governance Committee which will be 'responsible for ensuring a constant, disciplined attention to succession planning of Council member and... Committee leadership; broadening the recruitment of new Council members from OSH-ER@Dartmouth's entire membership. The reason for this change is to ensure that people proposed as Leadership Continued on Page 5

The goal to expand local appreciation of talented visual artists while enhancing the appearance of the office and realizing a commission for OSHER@Dartmouth's programs was achieved successfully beginning with the exhibit of Study Leader Stephanie Reininger's art in December of 2015.

first husband. They moved to Madison, WI, where he pursued a PhD in Finance at the University of Wisconsin, and she worked as a medical secretary. They soon began raising their family of four children.

Later, when he took a research sabbatical in London, Stephanie had a chance to explore the English watercolorists. She went to an exhibit of J.M.W. Turner's watercolor working sketches at The British Museum. She sought and received special permission to visit the archives of the Victoria & Albert Museum where she studied and absorbed as much as she could and to this day considers herself largely self-taught.

Prior to working in watercolor, she had tried batik, but the dyes used in the process made her ill and oil painting, while enjoyable, was cumbersome and, she felt, had the real potential to cause a house fire. Watercolor, on the other hand, could be transported with relative ease and was safe.

Her husband's career took them to many campuses, but in North Carolina and Arizona her inspiration and work blossomed. She joined watercolor societies, entered and was juried into national shows where she won many prestigious awards within the rarified world of Watercolor.

She has exhibited at the AVA Gallery, and her work can be seen at the Long River Gallery in White River Junction, as well as the Matt Brown Fine Art Gallery in Lyme, NH.

Those fortunate enough to be among her students learn from her in her studio above her barn/garage in Lyme, NH where she has lived since 2007.

For the many courses she

has taught at OSHER@Dartmouth and ILEAD and for her many other contributions she was awarded the Thomas B. Campion Award for Exceptional Service in 2013.

By-Laws Vote (cont.)

- Council members be experienced OSHER@Dartmouth members with qualifications needed by the organization.
- Creation of two new standing committees: Fundraising and Membership Development. Fundraising will be responsible for raising funds for the benefit of OSHER@Dartmouth and Membership Development will create programs and benefits to attract new members when needed.
- The Leadership Council will be enlarged, if needed, to include 12 members chosen by the membership, and the chairs of the following standing committees: Curriculum, Summer Lecture Series, Marketing and Communication, Finance, Planning and the Immediate Past President for a term of two years. The President may appoint additional members to the Council

when necessary subject to the approval of the Council and subject to the 23 voting member limit. The purpose of this change is to permit the Leadership Council to add members who bring needed expertise when needed.

Future amendments of the bylaws will be proposed by the Governance Council and require two-thirds vote by Leadership Council to be accepted. The purpose of this change is to expedite needed by-law changes without the expensive, time consuming current need to get the entire membership to vote.

If, after reviewing the current and proposed by-laws, you have questions and wish to discuss the proposed changes, members of our Leadership Council will take part in information sessions at the DOC House on the following dates:

- Tuesday, March 6, 11:00 AM -12:00 PM
- Wednesday, March 7, 9:30 AM -10:30 AM
- Monday, March 12, 1:00 PM -2:00 PM
- Tuesday, March 20, 2:30 PM -3:30 PM

These sessions are open to all OS-HER@Dartmouth members; there is no fee involved, and registration is not required.

Ballots will be mailed to all OSHER@Dartmouth members over the next few weeks. We ask that you submit your ballot by returning the pre-paid postcard included in that mailing. You can also submit your ballot to the OSHER@ Dartmouth office in person, or bring it to any of the info sessions listed above. All ballots must be received no later than Friday, March 30, 2018.
